RELEASE AND WAIVER OF LIABILITY**

In this agreement, Belleville Flatwater Racing Club Inc. operating as Belleville Dragon Boat Club, also operating as Belleville Paddling Club, shall *hereinafter be referred to as "BDBC."*

In consideration of being allowed to participate in any and all activities provided by "BDBC", as a member of kayaking program, and the following dragon boat programs: recreation paddling, or as a member of the race/festival team, or any and all events and activities involving recreation, fitness, or race team activities, I agree to the following:

I acknowledge I am participating voluntarily in any or all "BDBC" activities, events, or programs. In consideration of my participation I acknowledge and accept:

- I am aware of the risks and hazards which include, but are not limited to the sports of dragon boating and kayaking.
- Entering and exiting the dragon boat/kayak or capsizing a dragon boat/kayak.
- Executing strenuous and demanding physical training techniques and spinal cord injuries.
- Exerting and stretching various muscle groups and rapid movements and quick stops.
- Vigorous physical exertion and strenuous cardiovascular workouts.
- Falls due to wetness, uneven or irregular surfaces.
- Contact, falling, or colliding with a dragon boat, other boats, paddles, docks, or with other participants
- Extreme weather conditions which may result in dehydration, hypothermia, heatstroke, or sunstroke.
- Extended times in the water or underwater.
- Travel to and from competitive events and associated non-competitive events which are part of "BDBC's" activities.

I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown **EVEN IF ARISING FROM NEGLIGENCE OF THE "BDBC"**, its executive, coaches, members, volunteers, officials, agents, employees, participants, sponsors and advertisers, **WITH RESPECT TO ANY AND ALL INJURY DISABILITY, DEATH**, or loss or damage to persons or property **WHETHER ARISING FROM THE NEGLIGENCE OF THE "BDBC" OR OTHERWISE**, or of any person or persons who may from time to time be involved in any manner, including Belleville Parks and Recreation, and any Harbour Commission, or any person(s) who, with legal city of Belleville authority, has made any decision regarding the use of Belleville city property or buildings, situated in and around Victoria Park, Belleville, Ontario, for the purpose of "BDBC" use and or activities.
